This training also helps to understand how ISO/IEC 27001 and ISO/IEC 27002 relate with ISO/IEC 27003 (Guidelines for the implementation of an ISMS), ISO/IEC 27004 (Measurement of information security) and ISO/IEC 27005 (Risk Management in Information Security).
